SERVICE AGREEMENT

Global Water Resource rates are on file with the Arizona Corporation Commission. A copy of the current tariff schedule is available on our website, www.gwresources.com.

All bills are due and payable fifteen (15) days after the billing date. Any accounts left unpaid for more than thirty (30) days are subject to being turned off and sent to a collection agency. There is a reconnect charge of thirty dollars (\$35.00) for delinquent bills. Any customer requesting a re-read of a meter is charged twenty dollars (\$20.00) if the original read is correct.

***A security deposit is required to establish service. Security deposit is refundable after 12 consecutive months of account in good standing or at move out. Late payments received in the 12 month period may prevent the deposit refund. Once the deposit has been refunded, two or more late payments received in a 12 month period may require another deposit, and in some cases additional deposit amounts may be required up to the average of your two highest bills.**
