RATE CASE UPDATE

On April 22, 2025, the Arizona Corporation Commission approved a rate change for your water service effective May 1, 2025. Global Water will phase-in the new rates in three phases. The rates will include a basic service charge and a modification to commodity rates from the current three-tier rate structure to a sixtier rate structure. Customers will now be eligible for the Conservation Rebate Threshold (CRT) program.

The following pages provide detailed information on the new rates, the rate case expense surcharge, the effective dates, and the CRT program.

The approved rates are based on the cost of providing service and the need to continue to invest in improving your utility and our community. We will continue to work hard to provide you with safe, reliable, high-quality services.

RATE DESIGN

At Global Water, we use a rate design structure of six-tiers focusing solely on achieving lower water usage. Our approach to incentivize less consumption and disincentivize higher usage is by higher rates for higher consumption. It essentially means, the more water you use, the more you will pay. Our six-tier rate design includes preestablished thresholds based upon thousands of gallons used. We believe this provides a better incentive to consume less water. An additional benefit of using less water is through our Conservation Rebate Threshold program which includes direct savings described below.



CONSERVE WATER AND RECEIVE A REBATE

You are now eligible for a conservation rebate. For each month you use less than 4,000 gallons, you will receive a credit on your bill equal to 50% of your monthly consumption charge.

All customers are automatically a part of this program, so you do not need to sign up. An example of how the rebate works is shown below.

CHANGE IN RATES GLOBAL WATER – FARMERS WATER COMPANY, INC. DOCKET NO. W-01654A-24-0108

At its Open Meeting on April 22, 2025, the Arizona Corporation Commission ("Commission") approved a rate increase for Global Water – Farmers Water Company, Inc. ("Company").

The recent approval will increase the typical monthly bill for a customer with a 5/8-Inch X 3/4-Inch meter using approximately 3,500 gallons as follows:

The Final Decision also approved recovery of rate case expense, not to exceed \$100,000, recoverable through a monthly surcharge of \$0.80 per customer assessed over three years commencing May 2025. The surcharge will terminate if the expenses are recovered in full before the three-year period expires.
