CHANGE IN RATES

At its Open Meeting on June 11, 2024, the Arizona Corporation Commission (“Commission”) approved a rate increase for Global Water - Tortolita Water Company, Inc. (“Company”).

The recent approval will increase the typical monthly bill for a customer with a 1” meter using approximately 6,250 gallons as follows:
